ORDER APPROVING COMPLIANCE TARIFF AND CANCELING CCN

Issue Date: January 30, 2017

Effective Date: February 9, 2017

On November 30, 2016, the Commission issued an order granting Missouri-American Water Company a Certificate of Convenience and Necessity to operate a sewer system in the St. Charles County Jaxson Estates service area. The area was previously served by EMC of St. Charles County, LLC. The Commission directed MAWC to file an adoption-notice tariff sheet implementing EMC of St. Charles County, LLC's tariff in its entirety within ten days of the closing of the sale of assets between the two companies. MAWC submitted a tariff sheet with a February 9, 2017 effective date (Tracking No. YS-2017-0140) in compliance with the Commission's order. No objections to the tariff sheet were filed. The Commission finds the tariff sheet to be in compliance with the Commission's order and will approve the tariff sheet.

In the November 30, 2016 order, the Commission also stated that the CCN previously issued to EMC of St. Charles County, LLC would be canceled once the applicants notified the Commission of the closing on the transfer of sewer assets. MAWC submitted the Notice of Closing on January 3, 2017. The Commission will therefore cancel the CCN issued to EMC of St. Charles County, LLC.

THE COMMISSION ORDERS THAT:

1. The following tariff sheet, filed on January 10, 2017, and assigned Tracking No. YS-2017-0140, is approved to become effective on February 9, 2017.
