ORDER DIRECTING NOTICE AND JOINING BRANDCO INVESTMENTS, LLC AND HILLCREST UTILITIES COMPANY AS PARTIES

On October 1, 2007, Savannah Heights Industrial Treatment, Inc. ("Savannah Heights") filed an application with the Missouri Public Service Commission for authority to sell its sewer utility assets to Table Rock Lake Community Service, Inc. d/b/a Table Rock Lake Water Quality, Inc. ("TRLCS").

The application, which is in substantial compliance with the applicable provisions of Commission Rules 4 CSR 240-2.060 and 4 CSR 240-3.310, indicates that Savannah Heights is a Commission-certificated sewer corporation headquartered in Springfield, Missouri (Greene County), which holds a certificate of good standing from the Missouri Secretary of State and provides sewer service to approximately 100 customers in an unincorporated area of Taney County, Missouri. The application also indicates that Savannah Heights seeks the Commission's authorization to sell its sewer utility assets to TRLCS, a Missouri non-profit corporation headquartered in Kimberling City, Missouri (Stone

County) which is not currently subject to regulation by the Commission and did not join in the application. According to the application, upon Commission approval of this transaction, TRLCS intends to transfer ownership of the assets to Ozarks Clean Water Company ("OCWC"), a closely-affiliated Missouri not-for-profit corporation headquartered in Kimberling City, Missouri, which also did not join in the application and currently serves wastewater customers in the Table Rock Lake area under a contract with White River Valley Environmental Services, an experienced operator. Since the presence of TRLCS and OCWC as parties is necessary for a full and fair consideration of Savannah Heights' application, they will be joined as parties to this case.

So that other potentially interested parties are given notice and an opportunity to intervene in this matter, the Data Center of the Commission shall send a copy of this order to the County Commissions of Greene County, Taney County, and Stone County, Missouri, and to the Missouri Department of Natural Resources. The Public Information Officer of the Commission shall make notice of this application available to the members of the General Assembly who represent the citizens of Greene, Taney, and Stone County, and to the media serving those counties.

Proper persons wishing to intervene shall file an application to intervene with the Secretary of the Missouri Public Service Commission no later than October 30, 2007. Copies of the application to intervene should be sent to the parties listed below.

The requirement for a hearing is fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary, permit the parties to submit

evidence in support of the application by verified statement, and make a decision based on the verified pleadings.¹

IT IS ORDERED THAT:

- 1. Table Rock Lake Community Service, Inc. d/b/a Table Rock Lake Water Quality, Inc. and Ozarks Clean Water Company are joined as parties to this case.
- 2. The Data Center and the Public Information Officer of the Missouri Public Service Commission shall provide notice as set out herein.
