**ORDER RECOGNIZING CHANGE OF CORPORATE NAME**  
**AND APPROVING TARIFF**

PhoneTime, Inc., a New York corporation, submitted notification of its corporate name change to "PT-1 Communications, Inc." (PT-1) on March 23, 1998. PhoneTime also submitted a new tariff reflecting the new corporate name, revising some existing services and rates, and introducing twelve new debit cards. The company was certificated to provide resold intrastate interexchange telecommunications services on June 4, 1997, in Case No. TA-97-470.

PT-1 included with its filing an Amended Certificate of Authority from the Missouri Secretary of State reflecting its new corporate name. By letter filed April 14, 198, PT-1 extended the effective date of the tariff from April 21 to May 1. On April 22 PT-1 filed substitute pages with a May 1 effective date.

The Staff of the Commission (Staff) filed a memorandum on April 22 stating that it had reviewed the company's filings and had no objection to their approval as amended. Staff recommended that the name change be recognized and the proposed tariff be approved to become effective on May 1. Staff noted that Section 392.500, RSMo 1994, permits competitive

companies such as PhoneTime to increase their rates after ten days notice to customers and to the Commission; a reduction in rates requires only seven days notice. Staff stated that none of PhoneTime's existing customers will be affected by the rate revisions submitted in this case.

The Commission has reviewed PT-1's filings and Staff's recommendation, and determines that the change of name should be recognized. The Commission further determines that the tariff sheets as amended should be approved.

**IT IS THEREFORE ORDERED:**

1. That the change of corporate name from "PhoneTime, Inc." to "PT-1 Communications, Inc." is acknowledged.

2. That the following tariff pages are approved to become effective on May 1, 1998:

3. That this order shall become effective on May 1, 1998.
