ORDER APPROVING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

Friendship Village of West County (Friendship Village) applied to the Public Service Commission on May 1, 1998, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.440, RSMo 1994. Friendship Village asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. Friendship Village is a Missouri corporation, with its principal office located at 15201 Olive, Chesterfield, Missouri 63017.

The Commission issued a Notice of Applications and Opportunity to Intervene on May 12, directing parties wishing to intervene to file their requests by May 27. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked permission to intervene or

requested a hearing, the Commission may grant the relief requested based on the verified application.

Friendship Village filed a proposed tariff in conjunction with its application and filed substitute sheets on May 27. The tariff's effective date is June 15. Friendship Village's tariff describes the rates, rules, and regulations it intends to use, identifies Friendship Village as a competitive company, and lists the waivers requested. Friendship Village intends to provide interexchange telecommunications services including 1+ services, directory assistance, debit card services, and travel card services.

In its Memorandum filed on June 5 the Staff of the Commission stated that Friendship Village's proposed services are similar to existing IXC offerings. Staff recommended that the Commission grant Friendship Village a certificate of service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on June 15.

The Commission finds that competition in the intrastate interexchange telecommunications market is in the public interest and Friendship Village should be granted a certificate of service authority. The Commission finds that the services Friendship Village proposes to offer are competitive and Friendship Village should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that Friendship Village's proposed tariff details the services, equipment, and pricing it proposes to offer, and is

similar to tariffs approved for other Missouri certificated interexchange carriers. The Commission finds that the proposed tariff filed on May 1 shall be approved as amended to become effective on June 15.

IT IS THEREFORE ORDERED:

- 1. That Friendship Village of West County is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.
- 2. That Friendship Village of West County is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
