ORDER EXTENDING TARIFF SUSPENSION
AND SETTING SECOND PRE-HEARING CONFERENCE

The Commission issued its Order Suspending Tariff in this case pursuant to a motion filed by the Office of the Public Counsel (Public Counsel). United Telephone Company of Missouri d/b/a Sprint (Sprint) had submitted proposed tariff sheets on July 3, 1997, to introduce a new service which was captioned "Vanity Telephone Number Listings Service." On July 25 Public Counsel filed a motion to suspend that tariff and the Commission's July 31 order suspended the tariff for an initial period of 120 days to December 2. That order also set a prehearing conference for September 2. However, on August 28 the parties unanimously requested that the prehearing conference be canceled and that request was granted.

No further motions have been filed in this case either to reset a prehearing conference or to extend the tariff. Neither have the parties filed any indication of a stipulation or agreement. Therefore, the Commission will extend the suspension period and again order a prehearing conference.

The prehearing conferences are set not only for the parties but also for the Commission so that the Regulatory Law Judge to whom this case is assigned may monitor its progress and anticipate the necessity of scheduling contested hearings or may prepare orders with which to dispose of the case. Therefore, the prehearing conference originally scheduled for

September 2 is hereby rescheduled for December 9. The Commission will suspend the tariff for an additional two months to allow time for the prehearing to take place and for the parties to indicate how this case might best proceed.

IT IS THEREFORE ORDERED:

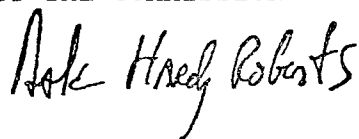
1. That the prehearing conference will be held on December 9, 1997, at 10:00 a.m.

3. That the effective date of Tariff No 9800017, is suspended for an additional two months until February 2, 1997.

4. That this order is effective on November 25, 1997.

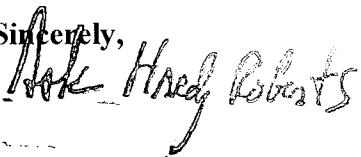
