JOINT MOTION TO MODIFY PROCEDURAL SCHEDULE

COME NOW the Staff of the Missouri Public Service Commission, Union Electric Company d/b/a as Ameren Missouri, the Missouri Department of Economic Development-Division of Energy, Earth Island Institute d/b/a Renew Missouri, and Walmart Stores, Inc. (collectively "Signatories") and hereby file this *Joint Motion to Modify Procedural Schedule* as follows:

- 1. On August 12, 2016, the Missouri Public Service Commission ("Commission") issued its order amending the procedural schedule in this case in response to the *Joint Motion to Modify Procedural Schedule* filed by the parties. The modification moved rebuttal testimony to August 25, 2015.
- 2. After extensive technical conferences and settlement discussions, a draft stipulation is being circulated among the parties. In order to allow those who wish to join in an opportunity to file a stipulation, the Signatories respectfully request the Commission modify the procedural schedule to allow for the filing of the stipulation and any testimony in support of or in opposition of that pending stipulation to be filed no later than August 31, 2016, with related adjustments to certain deadlines contained in the original procedural schedule in light of the extension of the deadline for rebuttal testimony by two weeks, as compared to the original rebuttal testimony due date. The Signatories therefore propose the following revised deadlines for the remaining milestones in the procedural schedule:
