ORDER APPROVING TARIFF

On August 3, 1994, Empire District Electric Company (Empire or Applicant) filed tariff sheets to comply with the Commission's Report and Order (Order) issued August 2, 1994.

The proposed tariff sheets are designed to increase annual electric revenues by approximately seven million three hundred fifty thousand dollars (\$7,350,000). The proposed tariff sheets would also increase the dollar amount charged for a cancelled disconnect service call and the reconnection charge, plus add a return check charge as agreed to in the Unanimous Stipulation and Agreement filed with this Commission on July 18, 1994.

The Order authorized the Applicant to file tariffs to become effective for service on and after August 15, 1994. A specific exception to this effective date was ordered for P.S.C. Mo. No. 5, Section 2, sheets number 9, 9a, 9b, 10 and 10a. These sheets are proposed to become effective for service on and after January 1, 1995.

On August 9, 1994, the Staff of the Missouri Public Service Commission (Staff) filed its Memorandum in which it recommended approval

of the Applicant's tariff. The Commission has reviewed both the tariff sheets as submitted by Empire District Electric Company and the Staff Memorandum. The Commission finds that the tariff is consistent with the Commission's Order dated August 2, 1994 and should be approved for service as set out above.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets filed by Empire District Electric Company on August 3, 1994 are hereby approved for service on and after August 15, 1994:
