**APPLICATION TO CANCEL CERTIFICATES
OF SERVICE AUTHORITY AND TARIFFS**

COMES NOW Quintelco, Inc. ("Quintelco" or "Applicant") and, by and through its attorneys, hereby respectfully requests the Missouri Public Service Commission ("Commission") to cancel its Certificates of Service Authority and Tariffs for intrastate interexchange telecommunications services and basic local exchange telecommunications services. In support of this Application, Quintelco states as follows:

1. Quintelco is a corporation organized and existing under the laws of the state of Delaware. Its principal place of business is located at 1 Blue Hill Plaza, Pearl River, New York 10965.

3. On September 9, 1997, Quintelco filed its application for a Certificate of Service Authority to provide intrastate interexchange telecommunications services in Missouri in Case No. TA-98-111. On April 14, 1998, the Commission issued its Report and Order granting Quintelco a Certificate of Service Authority to provide intrastate interexchange telecommunications services in Missouri, which Order became effective on April 22, 1998. Applicant's tariff became effective on April 22, 1998.

4. On February 2, 1998, Quintelco filed its application for a Certificate of Service Authority to provide basic local exchange telecommunications services in Missouri as a non-facilities-based reseller in all exchanges served by Southwestern Bell Telephone Company in Case No. TA-98-325. On September 17, 1998, the Commission issued its Report and Order granting Quintelco a Certificate of Service Authority to provide basic local exchange telecommunications services in Missouri as a non-facilities-based reseller in all exchanges served by Southwestern Bell Telephone Company, which Order became effective on September 29, 1998. Applicant's tariff became effective on December 9, 1999.

5. Since receiving its Certificates of Service Authority, Quintelco has never commenced business in Missouri and has never had any customers in Missouri. Since Quintelco has no current plans to offer either intrastate interexchange telecommunications services or basic local exchange telecommunications services in Missouri, Quintelco requests that the Commission cancel its Certificates of Service Authority to provide interexchange telecommunications services and basic local exchange telecommunication services, and the Tariffs filed and maintained in connection therewith.

6. Quintelco has no action pending or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or

rates, which action, judgment or decision has occurred within three (3) years of the date of the application.


7. No annual report or assessment fees are overdue.
