ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, AND SCHEDULING A PROCEDURAL CONFERENCE

On May 21, 2018, Union Electric Company d/b/a Ameren Missouri filed an application with the Missouri Public Service Commission seeking an order granting a Certificate of Convenience and Necessity (CCN) pursuant to section 393.170, RSMo 2016. The CCN would authorize Ameren Missouri to construct, own, and operate a wind generation facility to be constructed in Schuyler and Adair Counties in Missouri. Ameren Missouri's application also seeks approval of a Renewable Energy Standard Cost Recovery Mechanism (RESRAM), and a waiver of certain Commission rules. Ameren Missouri requests the Commission grant it a CCN no later than December 19, 2018.

The Commission will provide notice of the application to the general public and interested parties and set a deadline for intervention requests. If no movant is granted intervention, and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary for a determination of the application. In addition, the Commission will schedule a procedural conference for June 8. The Commission will take up the procedural schedule

proposed by Ameren Missouri as well as the company's motion for a protective order at the conference.²

THE COMMISSION ORDERS THAT:

- The Commission's Data Center shall provide a copy of this order to the County Commissions of Schuyler and Adair Counties, Missouri.
- 2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the Missouri General Assembly representing Schuyler and Adair Counties, Missouri and to the media serving those counties.
- 3. The Commission's data center shall provide a copy of this order to each party to Union Electric Company d/b/a Ameren Missouri's triennial IRP filing pending in File No. EO-2018-0038.
- 4. Any person wishing to intervene in this matter shall file an application to intervene no later than June 7, 2018. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission.
- 5. A procedural conference is scheduled for June 8, 2018, beginning at 10:00 a.m. The conference will be held at the Commission's office at the Governor Office Building, Room 305, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in this conference, may call
