RE: EVIDENTIARY HEARING AND LOCAL PUBLIC HEARING

On May 10, 2010, Timber Creek Sewer Company (Company) submitted a request to the Missouri Public Service Commission (Commission) asking that its sewer rates be increased by \$63,500 (approx. 9%). The Company cited a 202% increase in the Commission's annual utility assessment and a 28% increase in its annual electric utility rates in its request letter. Set out at the end of this notice is a table that summarizes the proposed revisions to the Company's rates including a monthly bill comparison. In addition, the Company has since requested a direct pass-through charge for the Commission's annual utility assessment and the inclusion of a contingency fund for emergency repairs, which is <u>not</u> reflected in the table below.

The Commission will hold an evidentiary hearing on the Company's request on January 5, 2011 to January 7, 2011 in Jefferson City, MO. New rates are not expected to take effect until February 2011.

Additionally, the Commission will be holding a local public hearing regarding the Company's proposed changes to the customer rates. The purpose of this local public hearing is to provide customers the opportunity to comment on the proposed changes to the Company's rates and to bring recent service-related problems to the Commission's attention.

The local public hearing will be held November 17, 2010, at the Wilson Theater located in the Platte County High School, 1501 Branch Street, Platte City, Missouri. The night's activities will begin with an informal question-and-answer session starting at 5:30 p.m. — with the local public hearing starting at 6:00 p.m. The facility at which this local public hearing is being held meets the accessibility standards required by the Americans with Disabilities Act.
