ORDER APPROVING TARIFF SHEETS IN COMPLIANCE
WITH COMMISSION ORDER

Effective Date: November 14, 2008

On August 28, 2008, the Commission issued an order approving a Unanimous Agreement Regarding Disposition of Small Sewer Company Revenue Increase Request (Disposition Agreement). The Disposition Agreement stipulated that Aqua Missouri, Inc., would file a revised tariff updating the tariff language for its collecting sewer extension rule. On October 1, 2008, Aqua Missouri filed revised tariff sheets, Tariff File No. YS-2009-0227, to comply with this clause of the Disposition Agreement. Aqua Missouri filed substitute tariff sheets on November 5, 2008. The tariff sheets bear an effective date of November 14, 2008.

The Commission's Staff filed its recommendation on November 5, 2008, in which it recommends approval of the tariff sheets. Staff worked with Aqua Missouri to draft the proposed rules and believes that the rules are reasonable and will result in more consistency with regard to funding of sewage treatment facilities among new customers. Staff believes that this tariff filing complies with the Disposition Agreement and the Commission's order.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission concludes that the compliance tariff is consistent with the Disposition Agreement and with the Commission's order approving that Agreement, and shall therefore approve the tariff filing.

THE COMMISSION ORDERS THAT:

1. Tariff File No. YS-2009-0227, filed by Aqua Missouri, Inc., on October 1, 2008, is approved as substituted effective November 14, 2008. The tariff sheets approved are:
