**NOTIFICATION OF ELECTION OF WAIVERS ON BEHALF OF SPRINT

Sprint Communications Company, L.P. (Sprint) hereby notifies the Commission of its election to waive and be exempt from the application and enforcement of certain commission rules and statutes set forth in paragraph 4 of Staff's October 18, 2011 Motion, pursuant to Sections 392.245.5(8), 392.420 and 392.461, RSMo, as amended by HB 338.

**Background of Sprint**

1. Sprint Communications Company, L.P. is an indirect wholly-owned subsidiary of Sprint Nextel Corporation and is a Delaware limited partnership with its principal office at 6200 Sprint Parkway, Overland Park, KS 66251. Sprint is duly authorized to provide competitive local exchange and interexchange services in Missouri. Sprint is an "alternative local exchange telecommunications company" as that term is used in Section 392.240 and has been granted a certificate in Case Numbers TA-96-424 and TA 97-269. Sprint has submitted the information in subsections (1)(B)-(F) of 4 CSR-2.60 in previous applications and incorporates the same by reference. See, Corrected Order Granting Request For Waivers, Case No. CE-2009-0099; Report and Order, Case No. TA-97-269.

2. Sprint does not have any pending action or final unsatisfied judgments or decisions against it in Missouri from any state or federal agency or court that involve its

customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Notification.

3. Sprint does not have any overdue annual reports or regulatory assessment fees in Missouri.


Commission filed October 18, 2011 in this File, to the extent not already waived for this entity.
