ORDER APPROVING TARIFF

Issue Date: February 4, 2009

Effective Date: February 7, 2009

On January 8, 2009, Aqua Missouri filed revised tariff sheets, Tariff File No. YS-2009-0501, in order to update its sewer extension rule. The Commission's Staff reviewed the tariff sheets and made a recommendation to the Commission that the tariffs be approved.

Staff indicated that the tariff revisions accomplish the following:

1. update and clarify definitions;
2. correct the formula for TempCIAC in the extension rule; and
3. combine and revise Exhibits A and B of the extension/expansion contract.

Only the second of these changes is related to the requirements previously ordered in this case. Staff worked with Aqua Missouri to draft the proposed tariff sheets and believes that the rules are reasonable and that the extension contract is improved by the changes.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission concludes that the tariff is consistent with the previously approved Disposition Agreement in this matter and shall therefore approve the tariff filing.

THE COMMISSION ORDERS THAT:

1. Tariff File No. YS-2009-0501, filed by Aqua Missouri, Inc., on January 8, 2009, is approved for service on and after February 7, 2009. The tariff sheets approved are:
