**STAFF’S SUPPORT FOR JULY 15, 2009 EXTENSION TO FILE ANNUAL REPORT  
AND OPPOSITION TO SEPTEMBER 15, 2009 EXTENSION**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”) by and through counsel, and submits its Support for July 15, 2009 Extension to File Annual Report and Opposition to September 15, 2009 Extension to the Missouri Public Service Commission (Commission), and states as follows:

1. On April 10, 2009, Central Rivers Wastewater Utility, Inc., (Central Rivers) filed its Application for Extension to File Annual Report (Extension Request) with the Commission requesting an extension from April 15, 2009 to September 15, 2009 to file its annual report.
2. Central Rivers Extension Request asserts no basis, nor explains, why a six (6) month extension for filing its annual report is necessary to allow its tax accountant to complete this filing. It is unreasonable for Central Rivers to withhold the filing of a public document for this extended period of time, especially in light of the fact that the next year’s data will have to be collected for reporting to the Commission in the 2010 annual report within three (3) months.
3. Staff suggests that an extension of three (3) months (until July 15, 2009) for Central Rivers to file its annual report is a reasonable timeframe to allow its tax accountant to complete the filing.

**WHEREFORE**, the Staff respectfully requests the Commission deny Central Rivers request for an extension of six (6) months to September 15, 2009, and suggests an order be issued allowing an extension of three (3) months to July 15, 2009, to file this annual report.
