NOTICE OF HEARING, ORDER RE-SETTING PROCEDURAL SCHEDULE, AND ORDER TO FILE RESPONSE

The Missouri Public Service Commission is giving notice of an evidentiary hearing, re-setting the procedural schedule in accordance with *Ameren's Third Proposed Procedural Schedule*¹ ("motion") subject to Craig Mershon's response, and directing Mr. Mershon to file a response to this order.

Union Electric Company d/b/a Ameren Missouri ("Ameren") filed the motion on January 13, citing the *Order Cancelling Hearing*, ² and alleging that Mr. Mershon has yet to serve discovery on Ameren. Ameren's proposals include the following:

That schedule complies with the Commission's regulation providing that this action shall "be processed in the timeliest manner possible [,]" sets ample time to prepare for hearing on this matter, and is coordinated with Staff. Staff filed a response to the motion on January 14, showing its limited availability dates for the hearing that Mr. Mershon seeks. The Commission will also consider a response from Mr. Mershon but, in the interest of administrative efficiency, the Commission will set the procedural schedule as Ameren proposed and Staff agreed. The Commission may change that schedule based on Mr. Mershon's response to this notice and order.

The Commission will also order Mr. Mershon to file a response to this notice and order. Mr. Mershon's response shall set forth either his agreement or disagreement with the procedural schedule as provided in this notice and order. Any response disagreeing with this order shall set forth an alternative schedule. If incomplete discovery is the basis for Mr. Mershon's disagreement, Mr. Mershon shall set forth the discovery that remains incomplete.

- 1. The procedural schedule shall be as set forth in the body of this notice and order.
- 2. The Commission will convene a pre-hearing conference on January 28, 2014, at 10:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. Any appearance may be either in person or through counsel, and may be either in the hearing room or by telephone. Any appearance by telephone shall be made by dialing 526-5904 or 866-630-9352 at the pre-hearing conference's start time.
