**STAFF’S NOTICE OF FILING AFFIDAVIT  
REGARDING METER TEST**

**COMES NOW** the Staff of the Missouri Public Service Commission and submits this Notice of Filing Affidavit Regarding Meter Test.

1. At the evidentiary hearing in this case, on January 31, 2008, the regulatory law judge directed Missouri-American Water Company to conduct a test of Complainant’s water meter, with said test to be witnessed by a member of the Staff, and directed the Staff to submit to the Commission the affidavit of the Staff member who witnessed the meter test. See Transcript, page 54, line 13 – page 55, line 12; also Transcript, page 69, lines 18-25.

2. Missouri-American tested Complainant’s water meter on February 7, 2008, and Staff witness Jerry Scheible witnessed the said test. Missouri-American thereafter submitted the results of the meter test as Late-Filed Exhibit 8, on February 19, 2008.

3. Attached hereto is the Affidavit of Jerry Scheible, in which Mr. Scheible states that he witnessed the said test, and that Exhibit 8 fairly represents the results of the said test.


