1. On June 2, 2021, the Commission issued its *Order Granting Certificate of Convenience and Necessity*, authorizing Missouri-American Water Company ("MAWC") to install, own, acquire, construct, operate, manage, and maintain a sewer system in and around Taos, Missouri, in the area served by the City of Taos, Missouri ("Taos System").
