
1. The above-referenced working docket was established by the Commission to review the economic, legal and policy considerations of District-Specific Pricing and Single Tariff Pricing. At the conclusion of an on-the-record presentation on November 9, 2010, the Commission gave the Parties the opportunity to file a Brief addressing the subject matter generally or specifically addressing issues raised in the on-the-record proceeding. The Commission gave the parties until December 15, 2010 to file such Brief.
