## **STATUS REPORT**

**COMES NOW** Missouri-American Water Company (MAWC or Company) and, as its Status Report, respectfully states as follows to the Missouri Public Service Commission (Commission):

- 1. Representatives of MAWC, the Commission Staff and the Office of the Public Counsel participated in a public meeting on November 21, 2013, in Stonebridge Village, Branson, Missouri, to generally discuss the issues that are the subject of the underlying complaints. MAWC intends to establish future dates and times where its personnel will be available at the subdivision to answer individual customer questions.
- 2. MAWC will also be performing an individual audit of every Stonebridge bill and then creating a statement for each customer that identifies, on an individual basis, what has transpired as to the customer's account and the customer's current balance.

  MAWC's plans on sending the statements out in December.
- 3. In the meantime, MAWC will make no collection efforts, add no interest, initiate no disconnects, impose no penalties, or take any other debt collection actions concerning Stonebridge customers while the bill review is underway.

**WHEREFORE**, MAWC respectfully requests that the Commission consider this Status Update, pending the filing of MAWC's answer in this consolidated matter.
