## ORDER RECOGNIZING NAME CHANGE

On July 14, 2023, YourTel America, Inc., submitted a letter advising that it has changed its name YourTel America, Inc. d/b/a MAXSIP TEL.

On July 25, 2023, the Staff of the Commission (Staff) filed a recommendation indicating the company had complied with all statutory and regulatory requirements for changing its name. Staff recommended that the Commission recognize the name change. The Commission will do so.

To allow MAXSIP TEL to implement the name change expediently, the Commission finds it reasonable to allow this order to become effective in less than 30 days.

### THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of YourTel America, Inc., to YourTel America, Inc. d/b/a MAXSIP TEL.
2. This order shall become effective on August 5, 2023.
3. This file shall be closed on August 6, 2023.
