## ORDER CANCELING CERTIFICATES AND ACCOMPANYING TARIFFS

Issue Date: June 16, 2005 Effective Date: June 26, 2005

This order cancels the certificates of service and accompanying tariffs of Servisense.com, Inc.

On May 23, 2005, the Staff of the Missouri Public Service Commission filed a motion asking the Commission to cancel the certificates of service authority and accompanying tariffs of Servisense.com. The Commission issued a certificate of service authority to provide basic local telecommunications services to Servisense.com in Case No. TA-2001-45. The Commission granted Servisense.com a certificate of service authority to provide intrastate interexchange telecommunications services in Case No. TA-2001-46. Servisense.com also has tariffs approved by the Commission: Missouri Tariff No. 1 and Missouri Tariff No. 2.

On August 20, 2001, Servisense.com, Inc., filed for Chapter 11 bankruptcy protection in the United States Bankruptcy Court for the District of Massachusetts, Eastern District.<sup>1</sup> According to Staff, a liquidating plan has been confirmed by the Bankruptcy Court and Servisense.com has ceased doing business in Missouri. Staff also reports that

according to the website of the Missouri Secretary of State, that office revoked the company's certificate of authority to do business in Missouri on September 4, 2002, for failure to file its annual registration report.

Staff served its motion on the last known address of the company as filed with the Commission, the company's registered agent on file at the Missouri Secretary of State's Office, and counsel for the company's liquidating supervisor. No response to Staff's motion was received.

Under Section 392.410, RSMo Supp. 2004, the Commission has the authority to cancel a telecommunications corporation's certificate. After reviewing Staff's motion, the Commission determines that this company is no longer in business in the state. Therefore, the Commission finds that the certificates of service authority granted to Servisense.com, along with the accompanying tariffs, should be canceled.

To ensure that the company has had every opportunity to respond, the Commission will require its Data Center to serve this order upon the addresses for the company as listed in Staff's certificate of service.

## IT IS THEREFORE ORDERED:

- That the certificates of service authority granted to Servisense.com, Inc., in Case Nos. TA-2001-45 and TA-2001-46 are canceled.
- 2. That the accompanying tariffs, Missouri Tariff No. 1 and Missouri Tariff No. 2 are canceled.
- 3. That the Data Center of the Commission shall serve a copy of this order on the following:
