ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: July 19, 2007 Effective Date: July 29, 2007

On May 30, 2007, Time Warner Cable Information Services (Missouri) LLC on behalf of Kansas City Cable Partners ("KCCP") filed an application asking the Commission to cancel their certificates of service authority and accompanying tariffs. KCCP has been authorized to provide intrastate private line and interexchange telecommunications services by the Commission.

In Case Number TA-98-428, the Commission granted KCCP a certificate to provide intrastate private line and interexchange telecommunications services. KCCP's tariff, PSC MO No. 1 was also approved.

On June 12, 2007, the Staff of the Missouri Public Service Commission filed its recommendation. Staff noted that in Time Warner's application, the company referred to a certificate of service authority granted by the Commission in TA-88-232; however, that certificate has already been cancelled in TC-2004-0356. Staff also indicated that because the company requested cancellation of its certificate and tariffs no Time Warner entity is authorized to use the name Kansas City Cable

Partners, and because the company is no longer providing telecommunication services in Missouri, Staff recommends that the Commission issue an order canceling KCCP's certificate and tariff.

KCCP has no overdue annual reports or assessments and no pending action or unsatisfied final judgments or decisions against it in any courts which involve customer service or rates, which action, judgment or decision occurred in the last three (3) years.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Having reviewed Time Warner's application and Staff's Recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to "Kansas City Cable Partners" using the name American Cablevision (subsequently modified to Time Warner Cable) shall be canceled.

IT IS ORDERED THAT:

1. The certificate of service authority to provide intrastate private line and interexchange telecommunications services, granted to "Kansas City Cable Partners" using the name American Cablevision (subsequently modified to Time Warner Cable), in Case Number TA-98-428, is canceled.

2. KCCP's tariff, PSC MO. No. 1, is canceled.

3. This order shall become effective on July 29, 2007.
