ORDER CANCELING CERTIFICATE
AND ACCOMPANYING TARIFF

Issue Date: September 4, 2008

Effective Date: September 14, 2008

On August 7, 2008, Long Distance of Michigan, Inc. d/b/a Fonitel (“Fonitel”) filed a letter asking the Commission to cancel their certificate of service authority and accompanying tariff.

In Case Number TA-2001-545, the Commission granted Fonitel a certificate to provide interexchange and nonswitched telecommunications services. Fonitel’s tariff, PSC MO No. 1, was also approved.

On August 27, 2008, the Staff of the Missouri Public Service Commission filed its recommendation. Staff indicated Fonitel has no overdue annual reports or assessments. Staff recommends that because the company requested cancellation of its certificate and tariffs and because the company is no longer providing telecommunication services in Missouri, the Commission issue an order canceling Fonitel’s certificate and tariff.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Having reviewed Fonetel’s request and Staff’s Recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to Long Distance of Michigan, Inc. d/b/a Fonetel shall be canceled.

IT IS ORDERED THAT:

1. The certificate of service authority to provide interexchange and nonswitched telecommunications services, granted to Long Distance of Michigan, Inc. d/b/a Fonetel, in Case Number TA-2001-545, is canceled.
2. Long Distance of Michigan, Inc. d/b/a Fonetel’s tariff, PSC MO. No. 1, is canceled.
3. This order shall become effective on September 14, 2008.
4. This case may be closed on September 15, 2008.
