On January 29, 2007, ABA Net, LLC (ABA) filed an Application for a Certificate of Service Authority to Provide Interexchange Telecommunications Services. Along with its application, ABA filed a proposed tariff P.S.C. Mo. Tariff No. 1 with a 45 day effective date, March 15, 2007, allowed by Commission rule 4 CSR 240-3.510(1)(C). On February 1, 2007, ABA filed a Motion for Expedited Treatment and a new tariff effective date of March 1, 2007. ABA states that its market potential will be affected unless it can provide services to Missouri customers on March 1, 2007. On February 2, 2007, the Commission ordered the Missouri Public Service Commission Staff (Staff) to file a Recommendation on or before February 16, 2007.

On February 6, 2007, ABA filed substitute sheets per the Staff. Staff reviewed the substitute sheets. Staff requested another substitute sheet on sheet 20 be filed to put the Commission's customer specific pricing language. On February 16, 2007, ABA filed the substitute sheet with the acceptable customer specific pricing language. Staff reviewed the substitute sheet and recommends approval.
