Affordable filed an adoption notice and revised tariff sheets on April 24, 2003, which reflect a proposed effective date of June 6, 2003. Since the last Status Report filed on October 9, 2002, Affordable has also completed the negotiation of interconnection and/or resale agreements with incumbent local exchange companies in its service area as follows:

- By letter filed October 31, 2002, Affordable adopted the Southwestern Bell Telephone Company M2A interconnection agreement.
- Affordable's interconnection and resale agreement with ALLTEL Missouri, Inc., was approved by the Commission on December 13, 2002 (Case No. CK-2003-0164).
- The Commission approved the resale agreement between Affordable and Spectra Communications on February 6, 2003 (Case No. TK-2003-0221).

4. Affordable's resale agreement with Sprint Missouri, Inc., is pending before the Commission in Case No. TK-2003-0407. Staff has requested an extension until May 23, 2003, to file its recommendation on the resale agreement.
