NOTICE OF DISMISSAL AND ORDER CLOSING FILE

TUK LLC (“TUK”) was granted a Certificate of Convenience and Necessity to provide sewer service in Case No. WA-2015-0169, et al. In the Commission’s Order granting the Certificate of Convenience and Necessity, TUK was directed to file a small utility rate case within a certain time. Consistent with that Commission order, on January 31, 2017, TUK submitted a request for a \$1 increase in its annual sewer operating revenues. On May 12, TUK submitted a Notice of Voluntary Dismissal, as permitted under Commission Rule 4 CSR 240-2.116(1) stating that it does not wish to pursue a rate increase. In the filing, TUK indicates that it provided the Commission’s Staff and the Office of the Public Counsel (“OPC”) information to review TUK’s rates. TUK states that neither Staff nor OPC object to the dismissal.

Commission Rule 4 CSR 240-2.080(13) allows responses to be filed within ten days of the filing of a pleading. More than ten days have passed and no responses have been filed to TUK's Notice of Voluntary Dismissal. Since Commission Rule 4 CSR 240-2.116(1) permits the voluntary dismissal of an application without an order of the Commission, the Commission hereby provides notice of the voluntary dismissal. The Commission will order the file to be closed.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall close this file.
2. This order shall be effective when issued.
