Dear Mr. Woodruff:

The name change for YourTel America's *wireless* ETC designation, of which the Commission was previously given notice, has changed. The previously-designated fictitious name was not available in the Secretary of State's office.

The new, fictitious name under which YourTel America will provide wireless ETC services in Missouri has now been registered with the Missouri Secretary of State. A copy of the Registration of Fictitious Name form filed by YourTel is attached to this letter. Since the fictitious name is slightly different than previously recited, YourTel provides the following revised notice to the Missouri Public Service Commission, pursuant to 4 CSR 240-31.130 (2) (N) and new 4 CSR 240-28.030 (9):

- 1. The old name is YourTel America, Inc., f/k/a The Pager Company. The new name is YourTel America, Inc. d/b/a Missouri FerraCom.
- 2. YourTel's Certificate of Authority from the Missouri Secretary of State is on-file with the Commission in Case No. CO-2008-0334 (Exhibit A to Application) and is incorporated by reference herein. The fictitious name registration filed with the Missouri Secretary of State is attached.
- 3. Existing wireless ETC customers of YourTel America have been given written notice of this name change.

- 4. The company will continue to comply with all applicable laws and rules pertaining to the ETC designation.
- 5. The company's contacts in EFIS have been reviewed and are correct.

The requests for cancellation of YourTel America, Inc.'s *wireline* certificates and tariffs, filed on November 5, 2015 in Non Case Related Filing BCES-2016-0228, remain unchanged. The requests for cancellation of YourTel America, Inc.'s *wireline* ETC designations, filed on November 24, 2015 in Non Case Related Filing BCES-2016-0228, remain unchanged.
