On June 3, 2015, the Staff of the Missouri Public Service Commission filed a motion requesting Infotelecom, LLC ("Infotelecom") certificate of service authority to provide competitive basic local and interexchange telecommunication services in the State of Missouri be cancelled.

In File Number CA-2006-0033 and XA-2006-0032, the Commission granted Infotelecom a certificate of service authority to provide competitive basic local and interexchange telecommunication service in the State of Missouri.

Staff states in its motion that Infotelecom contacted Staff via the company's Statement of Revenue for the FY-2016 Mo PSC Assessment stating Infotelecom was no longer providing service in Missouri and requested the Commission cancel Infotelecom's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide competitive basic local and interexchange telecommunications services.

On June 5, 2015, the Commission issued an Order Establishing Time to Respond allowing any parties to file an objection or request a hearing to do so no later than June 15, 2015. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority granted to Infotelecom, LLC, shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide competitive basic local and interexchange telecommunications services granted to Infotelecom, LLC, in File Numbers CA-2006-0033 and XA-2006-0032, is canceled.

- 2. This order shall become effective on June 29, 2015.
- 3. This case may be closed on June 30, 2015.
