On November 20, 2013, Peaceful Valley Service Company (Company) submitted a request for increases in its annual sewer and water operating revenues to the Missouri Public Service Commission (Commission). The reason for the increase is to cover increases in expenses and new investments in the Company's sewer facilities.
