COMES NOW Rex Deffenderfer Enterprises, Inc., hereinafter "RDE," pursuant to 4 CSR 2403.640(7), states to the Missouri Public Service Commission, hereinafter "Commission," as follows:

1. Applicant is a Missouri corporation with its principal office and place of business located at 1782 North Deffer Drive, Nixa, Missouri 65714, whose office phone number is 417-725-5305 and whose fax number is 417-725-8251. Applicant is in good standing with the Secretary of State. See Exhibit "A" attached hereto.

2. Applicant provides water service under a certificate of convenience and necessity granted by the Commission on the 7th day of August, 1977, in Case No. WA-77-83, and is a "public utility" as that term is defined in Section 386.020(32), R.S.Mo. and is subject to the jurisdiction, control and regulation of the Commission.

4. Applicant does not have any pending action or final unsatisfied judgment or decisions against it from any state or federal agency or court, which involves customer services or rates.
5. Applicant has no Annual Report nor assessment fees overdue.
6. Applicant is requesting under Section 4 CSR 240-3.640(7) an extension of 60 days for submitting its Annual Report due on April 15, 2007, for the following reasons:
 - (a) Applicant is not a large water company and the sole owner of the shares of Applicant is LaVada Cottrill, who is primarily responsible for all the business activities of the water company;
 - (b) Applicant has four (4) income tax Annual Reports to file by April 15, 2007, and has installed a new software program which is still being implemented;
 - (c) Merle Cottrill, the husband of LaVada Cottrill has passed on and had been the plant manager for the water company, with that work having passed in many respects to LaVada Cottrill; and
 - (d) During the past year, the corporation has elected to become an S-corporation with accounting ending on December 31, which has generated more accounting work for filing income taxes for 2006, but should in the future, allow the Applicant to use the same information to file its Annual Report to the Commission as is generated by its account records for its income taxes for the calendar year.

7. Applicant foresees no reason why the 2008 Annual Report cannot be timely filed.
8. Applicant states that it will reasonably require some 60 additional days beyond April 15, 2007, for Applicant to file its Annual Report to the Commission for 2007.


WHEREFORE, Applicant prays the Commission enter its Order:


