(2) The Applicant is registering to provide (a) basic local exchange and exchange access telecommunications service and (b) interconnected voice over Internet protocol service in all exchange in Missouri. The exchanges in which the Applicant seeks authority are listed in the approved tariffs of the respect incumbent local exchange carriers ("ILECs"). The Company's proposed service areas will mirror the respective exchange boundaries of each ILEC and shall be no smaller than an exchange.

(3) That the Applicant is legally, financially, and technically qualified to provide basic local exchange and exchange access telecommunications services and interconnected voice over Internet protocol services;

(4) That the Applicant is ready, willing, able, and will comply with all applicable state and federal laws and regulations imposed upon providers of basic local exchange and exchange access telecommunications services and interconnected voice over Internet protocol services;

(5) That the Applicant will charge and collect from its end user customers on basic local exchange telecommunications services and interconnected voice over Internet protocol service, and remit to the appropriate authority, fees and surcharges in the same manner as are charged and collected upon end user customers of local exchange telecommunications service and remitted by local exchange telecommunications companies, including but not necessarily limited to:

- (a) Telecommunications programs under section 209.255, RSMo;
- (b) Missouri universal service fund under section 392.248;
- (c) Local enhanced 911;
- (d) Any applicable license tax;

(6) That the Applicant will remit the annual assessment imposed by the Commission under section 386.370, RSMo;

(7) That the Applicant will file, either directly or indirectly through an affiliated competitive local exchange carrier, with the Commission an annual report at a time and covering the yearly period fixed by the Commission;

(8) That the Applicant has established a process for handling inquiries from customers concerning billing issues, service issues, and other consumer-related complaints. The Commission may direct consumer complaints to:
