NOTICE OF CONTESTED CASE AND ORDER DIRECTING FILING

On May 4, 2017, the Commission's Staff filed the *Motion to Revoke Authority*, a copy of which is attached. That filing constitutes a complaint, which requires the Commission to set a hearing.¹ The requirement of a hearing on such issues signifies a contested case.² A contested case is a formal hearing procedure, but it allows for waiver of procedural formalities and a decision without an evidentiary hearing, including by stipulation and agreement.³ The Commission's regulations provide for discovery at 4 CSR 240-2.090.

THE COMMISSION ORDERS THAT:

1. Coast International, Inc., shall file an answer no later than June 4, 2017.

MOTION TO REVOKE AUTHORITY

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and moves for the Missouri Public Service Commission (Commission) to revoke the authority to resell telecommunications services in Missouri of Coast International, Inc. (Company) and states as follows:

1. On January 30, 1990, Coast International filed an application in Case No. TA90156, to resell telecommunications services in Missouri. On April 17, 1990, the Commission granted the Company the authority to resell telecommunications services throughout Missouri.

2. Section 392.611(2) requires telecommunications providers to submit an annual report to the Commission along with other necessary information to calculate assessments. The requirements telecommunications providers must meet are further explained and codified in 4 CSR 240-28.040 (reporting) and 4 CSR 240-28.050 (assessments).

3. The Commission's *Report and Order* in Case No. TA90156 required the Company to comply with all applicable Commission rules except those specifically waived by the Commission, including filing a "Missouri-specific annual report".

4. Staff's January 31, 2017, letter to Coast requesting its 2015 Statement of Revenue was returned to sender and two of its July 5, 2016 emails bounced back stating the email addresses could not be found. Staff has received no contact from the Company in response to its emails. The company has failed to:

- a). File a statement of revenue for 2015.
- b). Submit its assessment payment for 2015.
- c). Submit an annual report for 2015.

5. Due to the Company's failure to comply with the applicable statutes, rules and orders, Staff moves for the Commission to revoke the Company's authority to resell telecommunications services.

WHEREFORE, Staff respectfully recommends the Commission revoke Coast International, Inc.'s authority to resell telecommunications services in Missouri.




