ORDER RECOGNIZING CHANGE OF CORPORATE NAME
AND RECOGNIZING FILING OF ADOPTION NOTICE

Harcourt Telco, L.L.C. (Harcourt or Applicant), submitted its application for approval of a name change on January 31, 2000, designed to reflect that it has changed its fictitious name and will be operating under the name Harcourt Telco, L.L.C., d/b/a Maverix.net, Inc. Applicant submitted an adoption notice originally effective February 1, 2000, with documentation issued by the Missouri Secretary of State evidencing the change in corporate name. On February 9, 2000, the Applicant submitted an adoption notice in the form required by the Commission and on February 14, 2000, submitted a revised adoption notice page in accord with Staff requests. The revised adoption notice page has an effective date of March 15, 2000.

On February 22, 2000, the Commission's Staff filed its recommendation. Staff recommends that the Commission issue an order recognizing the change of fictitious name and approving the adoption notice.

The Commission has reviewed the Applicant's filing and finds the name change should be recognized and the adoption notice approved.

IT IS THEREFORE ORDERED:

1. That the change of fictitious name used by Harcourt Telco, L.L.C., from "Maverix.com, Inc." to "Maverix.net, Inc.", is acknowledged.
2. That the adoption notice denominated Missouri P.S.C. No. 1, First Revised Adoption Notice Page, filed on February 14, 2000, reflecting the change of fictitious name and assigned tariff file number 200000683, as substituted, is approved for service on and after March 15, 2000.
3. That this order shall become effective on March 15, 2000.
4. That this case may be closed on March 25, 2000.
