**REQUEST FOR COMMENTS AND NOTICE OF
FUTURE POTENTIAL WORKSHOP**

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Request for Comments and Notice of Future Potential Workshop* in this matter hereby states:

1. Staff filed a *Motion to Establish a Working Case*, regarding rules 20 CSR 4240-3.100(13); 20 CSR 4240-3.150; 20 CSR 4240-3.200(15); 20 CSR 4240-3.255; 20 CSR 4240-14.010; 20 CSR 4240-14.020; and 20 CSR 4240-14.030, which the Commission granted and ordered a workshop to be held January 21, 2020. Several interested stakeholders met for the workshop and provided feedback and possible solutions to various concerns in revising the rules.

2. Based on the discussions at the workshop, Staff now asks the Commission to order interested stakeholders to file further comments and suggested language for inclusion in the revised rules. Specifically, Staff asks the parties to respond to any comments previously filed, any comments discussed at the January 21, 2020 workshop, any proposed rule language, and any statutory

authority Staff, and ultimately the Commission, may need to consider as part of the rulemaking process. Staff asks the Commission to order that these comments be filed no later than March 20, 2020.

3. Additionally, the interested stakeholders determined that an additional workshop may be fruitful following the filing of the interested stakeholder comments. To that end, Staff has reserved room 450 of the Governor's Office Building for May 4, 2020. Additional details for the workshop, should it be necessary, will be provided in this docket on a future date.

WHEREFORE, Staff respectfully asks this Commission to order interested stakeholders to file comments and proposed language no later than March 20, 2020; to reserve the date of May 4, 2020, for a future potential workshop in this matter; and to grant such other and further relief as the Commission considers just in the circumstances.
