RESPONDENTS' AMENDED MOTION TO DISMISS

Respondents move to dismiss the Complainants' Amended Petition for the following reasons:

- 1. On August 4, 2016, Complainants filed their Complaint with the Missouri Public Service Commission ("PSC") requesting that the PSC turn over the water and sewer system of Carriage Oaks Subdivision, a small subdivision in Stone County with less than ten residents, to the Carriage Oaks Homeowners Association.
- 2. On September 16, 2016, Respondents filed their Motion to Dismiss the Complaint on the grounds that the PSC lacked jurisdiction over Carriage Oaks Subdivision.
- 3. On October 28, 2016, the PSC Staff ("Staff") filed its pleading in response to the Motion to Dismiss, alleging generally that the Staff believed Carriage Oaks Subdivision was subject to PSC jurisdiction even though it had been lawfully operated for more than ten years subject to the Missouri Department of Natural Resources jurisdiction and only allegedly came under PSC jurisdiction by virtue of Carl R. Mill's, developer of Carriage Oaks Subdivision, estate planning transfer. In this pleading, the Staff suggest three alternatives to resolving the dispute alleged in the Complaint, among which was to

turn over control of the water and sewer system to an appropriately organized not-for-profit water and sewer corporation.

- 4. Although the Respondents believe the Staff and Complainants' legal analysis is flawed and not supported, due to the extreme cost of litigation, Respondents elected to form a not-for-profit water and sewer corporation to hold and operate the water and sewer assets of Carriage Oaks Subdivision.
- 5. On January 18, 2017 the Respondents formed a Missouri not-for-profit sewer and water corporation appropriately organized under Section 393.825 and 393.900 RSMo, named Carriage Oaks Not-For-Profit Water and Sewer Corporation (the "Non Profit"). The filed Articles of Incorporation are attached. *See* Exhibit "A".
- 6. The Non Profit is organized to define its members as each person or entity that owns property within Carriage Oaks Subdivision and is or will receive water and sewer services from the Non Profit. This definition includes the Complainants should they choose to receive water and sewer services.
- 7. After formation, the Non Profit filed an application with the Missouri Department of Natural Resources to transfer the operating permit associated with the water and wastewater facilities. Additionally, the real property associated with the wastewater and water treatment facilities of Carriage Oaks Subdivision has been transferred to the Non Profit and recorded in the real property records of Stone County. See Exhibit "B".

ARGUMENT

Sections 386.080(49) and 386.020(59) RSMo define regulated water and sewer corporations subject to the PSC's jurisdiction as every corporation owning, operating, controlling or managing any plant or property engaged in distributing or selling or supplying for gain any water or for the collection, carriage, treatment or disposal of waste for gain. Despite the wide jurisdiction of the PSC, Section 393.847 and 393.933 RSMo. provides the PSC shall not have jurisdiction over the construction, maintenance or operation of wastewater or water facilities, service rates, financing, accounting or management of any not-for-profit sewer or water company.

Carriage Oaks Not-For-Profit Water and Sewer Corporation is a validly existing not-for-profit corporation existing under Sections 393.825 and 393.900 RSMo. Although Respondents deny that the PSC had jurisdiction over Carriage Oaks Subdivision at any time, the formation and transfer of water and sewer services to the Non Profit renders Complainants claims moot.

WHEREFORE, based on the above, Respondents request that the Public Service Commission dismiss the Complaint for lack of jurisdiction and for such other and future relief as the Public Service Commission deems just.



- 7. The Company elects to be subject to the General Non-Profit Corporation Law under Chapter 355 RSMO.
- 8. The Corporation shall have members. Members shall be comprised of those persons receiving services or agreeing to receive services in the geographic boundary of the area to be served by the Company and as otherwise provided in the Bylaws, consistent with the statutes under which the Corporation is formed. Membership shall not be transferrable. An initial membership fee may be imposed by the directors, refundable without interest in the event membership is terminated, consistent with the statutes under which the Corporation is formed.
- 9. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
- 10. This document shall be effective immediately upon filing with the Secretary of State of Missouri.
