SUBJECT: Staff's Recommendation for Approval of Tariff Sheets in Compliance with Commission Order

On August 7, 2000, North Oak Sewer District, Inc. (North Oak) submitted a complete new tariff to comply with the Commission's ORDER APPROVING APPLICATION (Order) issued on July 13, 2000 and effective July 25, 2000. The tariff sheets bear an effective date of September 6, 2000.

After its review, the Staff discussed with North Oak some proposed modifications to its proposed tariff. As a result of those discussions, North Oak submitted some substitute sheets on August 29, 2000 to incorporate the modifications.

I have reviewed this tariff filing. North Oak's proposed tariff is based on the Staff's example tariff for sewer utilities. It also incorporates the rates, charges, and service area boundary that were approved by the Commission. In my opinion the tariff is reasonable and complies with the Commission's Order.

Based on the above, the Staff recommends that the Commission issue an order approving the subject tariff, which is identified as set out below, for service rendered on and after September 6, 2000:
