On November 24, 2009, the Staff of the Missouri Public Service Commission filed a complaint against the above-named Respondents. In its complaint, Staff alleges that sewer service is being provided without the necessary authority from the Commission. Subsequently, Canyon Treatment Facility, LLC filed an application seeking authority to provide sewer service in the relevant service area.¹ In light of that application, Staff moves the Commission to stay the filing of answers in the complaint case.

The Commission finds that Staff's motion is reasonable and will grant the requested relief.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission's Motion to Stay Filing of Answers is granted.


