ORDER DIRECTING FILING

Between October 17, 2013 and November 13, 2013, the Missouri Public Service Commission (“Commission”) issued notice of complaints filed against Missouri-American Water Company (“MAWC”) in the above-captioned cases. On November 15, 2013, MAWC filed a *Motion for Consolidation and Extension of Time to File Answers* in each of these cases. In its motion, MAWC represents that the Commission’s Staff does not object to consolidation, but MAWC does not indicate whether the other parties object and does not state the position of the parties with regard to the requested extension of time. The Commission will offer an opportunity for the parties to respond to MAWC’s motion.

THE COMMISSION ORDERS THAT:

1. Any party wishing to respond to Missouri-American Water Company’s *Motion for Consolidation and Extension of Time to File Answers* shall do so no later than November 21, 2013.
2. Missouri-American Water Company is granted a temporary extension of time until November 22, 2013 to file any answers due prior to that date.

3. This order shall become effective immediately upon issuance.
