

tariffs adopting CassTel's tariffs. The FairPoint companies filed tariffs adopting CassTel's tariffs on June 2. The tariff sheets carry an effective date of July 3, which is the date set for the closing of the transaction by which the FairPoint companies will acquire CassTel's assets.

Staff filed its recommendation regarding the tariffs on June 19. Staff indicates that the tariffs comply with the Commission's order, and recommends that the Commission approve the tariffs to become effective on July 3. No other party has filed a recommendation regarding the tariffs.

Based on Staff's recommendation, the Commission determines that the tariffs comply with the Commission's order. The tariffs will be approved effective July 3.
