Staff's Response to Public Counsel's Application for Rehearing

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its Response to the Public Counsel's Application for Rehearing, states that it concurs in the response filed today by Atmos Energy Corporation.

After a thorough consideration of the issues and the positions of the parties, the Commission on February 3, 2010, consolidated the remand of Case No. GR-2006-0387, Atmos' previous rate case, into Case No. GR-2010-0192, Atmos' current rate case. Staff considers that resolution to be appropriate. The remand order of the Circuit Court of Cole County simply states "[t]he PSC's Report and Order issued on February 22, 2007 in Commission Case No. GR-2006-0387 is hereby reversed and remanded back to the Commission consistent with the Opinion of the Court of Appeals." The mandate of the Court of Appeals—which is addressed to the circuit court—states that "the cause is remanded . . . for further proceedings, all in accordance with the Opinion of the

Court herein delivered." The Court of Appeals' opinion stated "we reverse the Commission's decisions . . . and remand those matters to the Commission for further proceedings." The action taken by the Commission on February 3 is consistent with the remand order of the Circuit Court of Cole County and with the mandate and opinion of the Court of Appeals.

WHEREFORE, for the reasons set out above, Staff prays that the Commission will deny Public Counsel's Application for Rehearing.
