## ORDER GRANTING LEAVE TO FILE ANNUAL REPORT

Issue Date: April 17, 2017

Effective Date: April 17, 2017

The annual report<sup>1</sup> of a sewer company ("report") is due April 15.<sup>2</sup> That date was a Saturday, so the Commission's regulations provide that the report is due on Monday, April 17.<sup>3</sup> Central Rivers Wastewater Utility, Inc. ("the company") seeks leave to file the report in an incomplete state.<sup>4</sup>

The report is subject to the Commission's regulations,<sup>5</sup> which allow a variance under the same standards as the Commission's rules of practice and procedure,<sup>6</sup> which allow a waiver for good cause.<sup>7</sup> The company cites issues concerning the company's accountant, family health matters, and company personnel changes. Those issues constitute good cause.

Therefore, the Commission will grant the request, but the Commission will also order the filing of the complete report no later than 60 days from the date of this order.
