**MOTION TO OPEN CASE AND CANCEL CERTIFICATES OF SERVICE**  
**AUTHORITY AND ACCOMPANYING TARIFFS**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case and Cancel Certificates of Service Authority and Accompanying Tariffs, respectfully states as follows:

1. The above-captioned companies have been granted certificates of service authority by the Missouri Public Service Commission (Commission) pursuant to the Commission's authority under Section 386.250 RSMo 2000. Each of the above-captioned telecommunications companies (hereinafter referred to as the "Companies", or "Company") has marked on its 2004 Statement of Revenue form that it no longer wishes to retain its certificate of service authority. See affidavit of Helen Davis, Accountant II, Budget & Fiscal Services, attached hereto as Appendix A.

2. Each of the Companies also share the following common facts that support Staff's motion to open this case for the cancellation of the Companies' certificates and tariffs:

- a) Each Company is current on its annual report and owes no assessments.
- b) Each Company has no actions pending before the Commission.
- c) Each Company has indicated that it has no operations in Missouri.
- d) The Companies are in "good" or "active" standing with the Missouri Secretary of State's office according to its website.

3. Accordingly, the Companies seek cancellation of the following certificates and approved tariffs:

(a) Atlas Mobilfone, Inc. was granted an interexchange telecommunications service (IXC) certificate with approved PSC MO NO. 1 tariff in Case No. TA-2000-723 on June 16, 2000.

(b) Celebrate Communications L.L.C. was granted an IXC certificate with approved PSC MO NO. 1 tariff in Case No. TA-98-529 on August 3, 1998.

(c) Citylink of Kansas City was granted an IXC certificate with approved PSC MO NO. 1 tariff in Case No. TA-2000-378 on February 18, 2000.

(d) Steve's Wildcat Web, Inc. (SWWI) was granted an IXC certificate with approved PSC MO NO. 1 tariff in Case No. XA-2005-0021 on September 6, 2004. SWWI was granted a competitive local exchange carrier (CLEC) certificate in Case No. CA-2004-0568 on August 8, 2004. SWWI has no CLEC tariff.

4. Because the Companies have reported that they have no Missouri operations, there is no detriment to the public. Therefore, the Staff recommends that the Commission issue an order canceling the certificates and tariffs of the above Companies.

5. The Commission has the authority to cancel a telecommunications company certificate pursuant to Section 392.410.5 RSMo 2000, which provides:

“Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494 (Mo. App. 1989).

WHEREFORE, the Staff recommends the Commission issue an order canceling the certificates of service authority and the accompanying tariffs of the Companies as shown in paragraph 3 above.

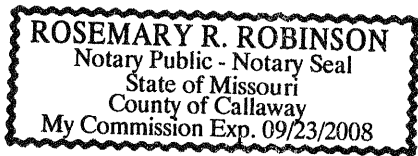
