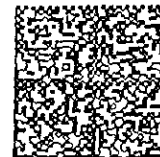

ORDER CANCELING CERTIFICATE AND TARIFF

Issue Date: October 2, 2008

Effective Date: October 12, 2008

On September 3, 2008, the Staff of the Missouri Public Service Commission filed an application requesting the Commission cancel the certificate of service authority and tariff of ezTel Network Services, LLC (ezTel Network) to provide intrastate interexchange telecommunications services, as well as its tariff.

In Case Number TA-2000-414, the Commission granted ezTel Network a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri. ezTel Network's tariff, P.S.C. MO No. 1, was also approved in the same case.

The Staff of the Commission attempted to locate ezTel Network through various avenues, but was unsuccessful. Staff stated the company filed for Chapter 11 and Chapter 7 bankruptcy, both were dismissed for failure to pay the required conversion fees. On July 23, 2008, Counsel for Staff contacted ezTel Network's former tax analyst and annual report contact for the company. Staff

was informed by the analyst that to her knowledge, ezTel Network does not operate anywhere in the United States, and she knows of no employees to whom Counsel can speak.

Staff recommended the Commission cancel ezTel Network's certificate of service authority and tariff.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's recommendation, the Commission finds that the certificates of service authority and tariff granted to ezTel Network Services, LLC shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to ezTel Network Services, LLC, in Case Number TA-2000-414, is canceled.
2. ezTel Network Services' tariff, PSC MO No. 1, is canceled.
3. This order shall become effective on October 12, 2008.

4. This case may be closed on October 13, 2008.
