ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: December 2, 2011

Effective Date: December 12, 2011

On November 17, 2011, the Staff of the Missouri Public Service Commission filed a motion requesting Telenational Communications, Inc., d/b/a T.N.C., Inc. ("T.N.C.") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XA-2003-0013, the Commission granted T.N.C. a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that T.N.C. failed to file its 2010 annual report according to the Missouri Secretary of State's Office, and its authority to do business in the State of Missouri was revoked on August 25, 2010. In addition, T.N.C. has not submitted a 2010 annual report and is delinquent in paying its fiscal year 2012 assessment to this Commission. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On November 18, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than November 29, 2011. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Telenational Communications, Inc., d/b/a T.N.C., Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Telenational Communications, Inc., d/b/a T.N.C., Inc., in File Number XA-2003-0013, is canceled.
2. Telenational Communications, Inc., d/b/a T.N.C., Inc.’s tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on December 12, 2011.

4. This case may be closed on December 13, 2011.
