On March 24, 2023,¹ the Staff of the Commission (Staff) filed motions requesting the Commission cancel or revoke the certificate of BlueBit Networks, LLC to provide basic local exchange and interexchange telecommunications service, as well as the registration to provide interconnected voice over internet protocol (VoIP) services.

On April 7, BlueBit Networks, LLC responded and requested an extension of time.

The Commission finds this request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. BlueBit Networks, LLC shall file its response to Staff's motion, or a request for further extension of time, no later than May 12, 2023.
2. This order shall be effective when issued.
