(hereinafter referred to as "GC" or "Seller") (together the "Applicants"), by their undersigned counsel, and for their response to the Commission's July 29, 2005 Order state the following:

- 1. Applicants state that the transaction described in its application is not complete.
- 2. On April 29, 2005, Matrix filed its application for a certificate of service authority to provide basic local telecommunications service along with a proposed basic local tariff. The case was assigned Case No. CA-2005-0393. Staff has discussed with the undersigned counsel certain changes to the basic local tariff and revised tariff pages were filed with the Commission on October 20, 2005. The Commission issued its order granting basic local telecommunications authority and approving Matrix's basic local authority in Case No. CA-2005-0393 on October 25, 2005.

- 3. On October 17, 2005 Matrix filed an adoption of the interconnection agreement between Southwestern Bell Telephone Company and XO Communications Services with the Commission, being Case No. VT-2006-0032.
- 4. Matrix believes that this matter is now ready for a recommendation by the Commission's Staff.
