**STAFF RECOMMENDATION**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

1. In the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Missouri Public Service Commission amend Frontier Communications International, Inc.'s (Applicant) Certificate of Service Authority to provide interexchange telecommunications service to reflect the new corporate name, Global Crossing North American Networks, Inc., effective October 12, 2000, in accordance with 4 CSR 240-2.060.

2. The application clearly sets out both the old and the new name to be used.

3. Applicant has furnished a copy of the Amended Certificate of Authority that is on file with the Secretary of State.


4. Applicant submitted revised tariff sheets to reflect the name change, to become effective on October 12, 2000.



Subject: Recommendation to Approve Proposed Name Change and Replacement Tariff

Date: September 28, 2000

On August 25, 2000, Frontier Communications International Inc. (the company or Frontier), a competitive telecommunications company, submitted a proposed replacement P.S.C. MO. No. 1 Tariff with an effective date of October 5, 2000. On September 26, 2000 Frontier submitted a revised filing with an October 12, 2000 effective date.

Frontier has received approval from the Secretary of State in Missouri to change its corporate name to Global Crossing North American Networks, Inc. A copy of the Amended Certificate of Authority is attached to Frontier's filing.

The Telecommunications Department Staff (Staff) has no objections to the replacement tariff, as amended, and recommends the commission amend Frontier's certificate of service authority to provide interexchange telecommunications service to reflect the new corporate name, Global Crossing North American Networks, Inc., and approve the following tariff pages to become effective October 12, 2000:
