STAFF RESPONSE TO ORDER DIRECTING FILING

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation states:

- 1. On June 20, 2001, Big River Telephone Company, LLC (Big River) filed its application for authority to provide basic local exchange, local exchange, exchange access and interexchange telecommunications services.
- 2. On June 20, 2001, Big River also filed a motion for expedited treatment in which it requested that the Commission issue its Order in this case prior to August 15, 2001.
- 3. On July 9, 2001, the Missouri Public Service Commission (Commission) issued an Order directing Staff to file a status report informing the Commission of when Staff will file its Staff Recommendation and Memorandum in this case.
- 4. Staff anticipates that it will be able to file its Staff Recommendation on August 6, 2001. Staff notes that the final intervention deadline in this case expires on August 2, 2001.

WHEREFORE, Staff recommends that the Commission issue its order in this case consistent with Staff's recommendations.
