## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: November 30, 2012Effective Date: December 10, 2012

On November 15, 2012, 360networks (USA) inc. ("360networks") filed an application requesting its certificate of service authority and accompanying tariff to provide basic local exchange, non-switched local exchange and interexchange telecommunication services in the State of Missouri be cancelled.

In File Number TO-2001-99, the Commission granted 360networks a certificate of service authority to provide basic local exchange, non-switched local exchange and interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

In its application, 360networks stated the Company was no longer providing service in Missouri and requested the Commission cancel its certificate of service authority and accompanying tariff.

On November 16, 2012, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than November 28, 2012. No objections or requests for a hearing were filed. On November 28, 2012, the Staff of the Commission filed its recommendation. Staff stated that 360networks is not deficient in the filing of the Company's annual reports, remittance of Commission assessments or remittance of any Missouri Universal Service Fund or Relay Missouri funds. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services and local exchange telecommunications dedicated, nonswitched local exchange private line services, and the company's accompanying tariff.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the Company's application and Staff's recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to 360networks (USA) inc., shall be canceled.

## **IT IS ORDERED THAT:**

1. The certificate of authority to provide intrastate interexchange telecommunications services and local exchange telecommunications services granted to 360networks (USA) inc., in File Number TO-2001-99, is canceled.

2. 360networks (USA) inc.'s tariff, P.S.C. Mo No. 1, is canceled.

3. This order shall become effective on December 10, 2012.
