STIPULATION OF DISMISSAL

COME NOW Total Call Mobile (“Total Call Mobile” or “Company”) and the Staff of the Missouri Public Service Commission ("Staff"), and stipulate and agree as follows:

1. Company hereby stipulates and agrees to relinquish its Eligible Telecommunications Carrier Designation effective as of midnight on November 30, 2016, and that the Commission may confirm such termination of that designation as of that date and time. Company takes such action as an independent business decision and does not thereby concede or admit to any of the allegations raised herein by Staff.

2. Based on the foregoing, Staff agrees that this proceeding has become moot other than for the Commission to confirm the termination of Company's designation as stated above. Subject to the Commission issuing such confirmation, pursuant to 4 CSR 240-2.116 Staff dismisses and withdraws its Motion for Provisional Revocation of the ETC Designation of Total Call Mobile, Inc. and Request for Order to Show Cause Why the Designation Should Not Be Permanently Revoked and any and all requests for relief filed herein.

3. Company represents that it is making a good faith effort to migrate its remaining Missouri customers to another Missouri ETC prior to its relinquishment of its Eligible Telecommunications Carrier designation.
